## Job Description

### ROLE AND RESPONSIBILITIES

Perform the manual functions for developing and maintaining company vineyards with an elevated skillset. Responsibilities include but are not limited to the following:

- Prune, tie, pick, train, weed, thin, de-leaf, plant, sucker, graft, harvest, or repair trellis, as needed to maintain or improve the condition of the vines
- Prepare and plant the vineyards
- Install trellis, irrigation, and drainage system in the new vineyards
- Properly maintain safety procedures in all production areas at all times, and to inform the Vineyard Supervisor of any safety problems that may arise

Non-essential duties may include other property maintenance or cleaning tasks, as requested.

### PHYSICAL REQUIREMENTS

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential duties of this job. Reasonable accommodations may be made to individuals with disabilities to perform the essential functions. While performing the duties of this job, the employee is regularly required to:

- Use hands to finger, handle, or feel objects, tools, or controls
- Reach with hands and arms
- Climb or balance
- Stoop, kneel, crouch, or crawl
- Walk, talk, and hear
- Lift and/or move 50 or more pounds
- See with close vision, distance vision, peripheral vision, depth perception, and the ability to adjust focus

### WORKING CONDITIONS

Ability to deal with problems involving several concrete variables in standardized situations. Must have the ability to identify and inform their supervisor of any safety problem.
- Other: Basic mechanical skills and aptitude, ability to work in a crew environment
